Résumé du cours – Objectifs - Course description – Targets

In times of peace and in times of war, Peace Mediation plays a major role in the management and resolution of violent political conflicts. A historically prestigious and respected practice, led by head of states, senior diplomats or the Vatican, contemporary mediation has known many transformations and is now engaged by all kinds of public and private local, national, and global actors. This class will help better understand the key challenges questioning the mitigation of today's violent confrontations.

Third party interventions by NGOs, Multilateral Organizations, Nobel Prize winners, individual experts, academics, or religious movements have greatly thriven in the past two decades. From the Northern Ireland peace process negotiated by US Senator Mitchell to the Israeli-Arab Camp David Accord brokered by President Jimmy Carter, from the Mozambique Sant'Egidio Mediation to a cease-fire and hostage negotiations, you will need to learn from a great array of mediation strategies to enhance your knowledge of international conflict resolution processes.

This course will provide students with **all the necessary theoretical and practical knowledge to understand the characteristics of mediation** as an alternative tool to end violent conflicts. Through **readings, simulations, and case studies,** students will get the opportunity to become familiar with practice of modern conflict resolution. Useful websites, multimedia resources, short movies and selected interviews will be presented to the class.



Evaluation - Assessment

Mediation simulation (40%)

Two mediation simulations will be organized in class, at the start and at the end of the semester. Instructions will be made available along with methodological advice. You will be asked to submit an individual online feedback and evaluation form after each simulation. Based on your role during this exercise, reports will include:

- a short presentation of your role in the simulations and a personal evaluation of how you 'played' it during the exercise.
- assessment of identified mediation techniques
- short developments on specific issues identified during and/or after the simulation

The Mediators: roles & techniques (40 % of the final grade, individual assignment):

With the teacher's approval, students will select an International Mediation occurrence, identify the mediator(s) involved and present its/their role(s). Attention should be paid to the type of mediator and style of mediation involved. Presentations of the mediator(s) involved should also highlight what can be learned from specific methods of international intervention. Students are strongly encouraged to get direct contact and interact with mediators involved in the selected cases.

Students can also conduct a short interview with a mediator (short 3-5min. edited video or audio interview). Focusing on a mediator, the interview should underline a specific technique, a valuable experience in the field of mediation, participation to a mediation process, etc.

<u>Please upload (OneDrive), by the end of the semester, a 5 pages "Mediator portrait" presenting the selected</u> mediator, its achievements in the field of conflict resolution, including style and type of mediation (use the <u>'Third-Party Engagement' Frame</u>), techniques used, along with a short bibliography.

Mediation 'bookshelf': Readings, Participation in class (30% of the final grade, individual assignment)

Students will be asked to complete an online form before each session.

Readings will be made available at the start of the semester and discussed in class.

A list of books and journal articles on International Mediation and Conflict Resolution will be presented to the class.
