Résumé du cours – Objectifs - Course description – Targets

The purpose of this seminar is to familiarize students with the actors driving European integration, and to compare those with other international organisations and national administrations. It will thus stress the specificities of agents working in the "Brussels bubble", raise concrete knowledge about the field of Eurocracy and connect these issues with broader debates of integration and of comparative politics. It will particularly stress the disembeddedness of Brussels-based agents from the rest of society (the 'no demos' thesis, a common feature of IOs) and address the prospects of reembedding European issues in the territories of member states (reappropriation by national administrations, local actors). This remoteness of European affairs led commentators to argue for a depoliticization of the field of Eurocracy, with an emphasis on bureaucracy and a strong logic of compromise between various stakeholders when forging in common the rules of the Single Market. The consequence is that EU professionals, working for or orbiting around the institutions, have unique profiles and trajectories that the seminar will unpack.

EU policies are also shaped by actors located outside of Brussels. Other EU institutions and national administrations are applying, diluting or driving the development of contemporary European politics. The seminar will thus take students to Luxembourg, Frankfurt and other European cities to show that judges, central bankers and grassroot NGOs are among a handful of actors that accompany the organs of the institutional triangle (Commission, Council, Parliament) in the drafting and implementation of European policies

An oral presentation (by groups of 4-5, tbc), of maximum 20 minutes (with a Powerpoint presentation) + a paper on the same topic (with the same group) that takes into accounts the feeback of the course supervisors on the oral presentation (due for the last class).
